SIGNIFICANT ACTIVITY:

Accidents dominated our calls for service once again this month with 22 accidents and 5 other accident related complaints this month. One of our patrol cars was struck from behind by a wrecker responding to an accident. Minor damage was done to the patrol car and no one was injured.

On December 12th, several Reserve Officers attended the annual "Shop With A Cop" program at Walmart. This is the first year that we have participated with this program.

Detectives from Adrian City PD worked with officers from our department to close out a string of burglaries from vehicles in the township that occurred last August. Four teenage suspects were arrested in the City of Adrian and linked to our cases. All four were charged with felonies and are awaiting trial. These same individuals were charged in several other cases within the county.
