DEPARTMENT UPDATE:

DIVE TEAM: Officer Mercer just completed her Dive Instructor course and can now teach dive related classes. Our department will be hosting training classes for Fire and Police based divers within the county. Our plan is to offer a significant discount in training fees while still recouping the money that we have invested in her training.

We were fortunate to receive a new dive boat from Bay County Sheriff's Office for our team. The purchased new boats and donated this boat to us through the federal surplus LESO program. It came fully equipped with the exception of a radio and life jackets. We will be training on the operation and maintenance of this boat later this week.

MONTHLY ACTIVITY: This months activity is down do to several factors. Sgt. Poe and I each took a week vacation this month and Officer Mercer was gone for two weeks for dive instructor training. We have been working hard playing catch up ever since.

MITCHELL PARK: Mitchell Park was vandalized this month by three teenage boys. By working with Carl and Debbie reviewing security video tapes, we were able to ID the three boys and get full confessions of what they had done. We are attempting to work out a plan to have the boys do community service at the park while the parents have agreed to pay restitution as well as help repair damage done to the roof. The boys have had no prior contacts with Law Enforcement and it appears this was an isolated case of poor judgement.
