### DEPARTMENT UPDATE:

#### MONTHLY ACTIVITY:

Yes, it's that time of year again. We have been busy with car vs. deer accidents. We have noticed during evening patrol hours that there seems to be a large healthy deer population in the township. We are seeing a lot of deer. We want to remind everyone to slow down and be alert for animals crossing the road.

The State of Michigan just completed a state wide *Sex Offender Registration Enforcement*. Each department in the state was asked to do a random contact of sex offenders in their jurisdiction and verify that they were in compliance of the sex offender registration act. We have 18 convicted and registered sex offenders in the township and we had 100% compliance.

We have seen a steady increase in civil & domestic related incidents. We have been busy trying to referee family and neighborhood "squabbles". While these are not usually criminal in nature, they take a lot of time to mediate. Usually we are looked upon as the "bad guy" because we can't take action against someone. Our role is to mediate and make sure the situation doesn't escalate into a criminal situation.
