Monthly Activity:

On May 1st Officers Escott and Schmidt were enroute to training at 0630 am. They encountered a vehicle on Russell Rd. that was driving in an erratic manner. The driver of the vehicle was traveling at a high rate of speed and running on coming traffic off of the road. They contacted Central Dispatch and advised them as to the situation and requested assist from other units. Since no other units were available and fearing for the safety of the general public, Officer's Escott and Schmidt attempted to stop the vehicle. The driver did not stop and attempted to flee from them. The driver eventually crashed into a ditch and was apprehended by Escott and Schmidt. The driver was found to be intoxicated and lodged by MSP Trooper Northrup at the Lenawee County Jail.




