DEPARTMENT UPDATE:

MONTHLY ACTIVITY:

While on patrol during the evening hours of November 2nd, Officer Mercer noticed a pick up truck traveling on Rogers highway that appeared to be trying to duck from her. Since she had not observed any apparent violation, the activity raised her suspicion. She left the area and then returned "blacked out" to observe the vehicle which had pulled into a driveway. As the driver pulled back onto the roadway, Officer Mercer ran the plate on the truck and found that it was registered to a car, not a truck and was expired. She made a traffic stop on the vehicle and discovered that the driver was a convicted felon and had a suspended drivers license. He was also intoxicated and had a quantity of drugs on him. The vehicle had no insurance. The passenger in the vehicle was wanted on outstanding warrants. Both men were placed lodged at the Lenawee County Jail.

While returning from the court house on November 29th, Officer Mercer pulled into the Midway Market parking lot. Just prior to exiting her vehicle, she noticed a school bus pull up near the store and activate its red lights. Just as kids were stepping from the bus, Officer Mercer saw a vehicle southbound on Occidental disregard the red flashing lights of the bus and drive passed it. She made a traffic stop on the vehicle and discovered that the driver was suspended. She placed the driver under arrest and lodged him at the Lenawee County Jail.
