Monthly Activity:

Weather related complaints still account for the highest activity rate within the month of February. Officers handled 15 accident complaints this month with 5 of them being injury accidents.

Officers Escott and Schmidt continue to work with OMNI officers in several drug related cases with three search warrants executed within the township. The quantities of narcotics seized in these cases continue to be larger than we have normally seen.

Sergeant Grayer and Officer Escott recovered a stolen vehicle that they found parked on Pocklington road. Inside the vehicle they discovered an occupant who is believed to have stolen the vehicle in Oakland County. He also had in his possession several stolen credit cards and ID's. The suspect is lodged at the Lenawee County Jail on multiple felony warrants. Once we are finished locally, he will be sent to Oakland County to face pending charges there.
